- Work must be designed and executed by accepted artist. Work done by production studio NOT ACCEPTED.
- 75% or more of artist's exhibit must consist of artist's original work. No more than 25% may be giclees or reproductions.
- Work prepared with commercial patterns, molds, kits, etc. NOT ACCEPTED.

Entry Procedure:

- Four clear slides or photos representative of your work
- One booth slide
- One \$5.00 check for jury fee
- One \$50.00 check for each 10x10 booth space
- Self-addressed, stamped envelope for slide return

Selection Process:

- Artists will be selected by a jury.
- Aesthetic quality and number of artists in each medium will be the sole criteria of the jury, whose decision will be final.
- All exhibiting artists must go through the selection process and may not share or split their booth with others.
- Artists will be notified and booth fees deposited in a timely manner.

Requirements:

- No lawn stakes
